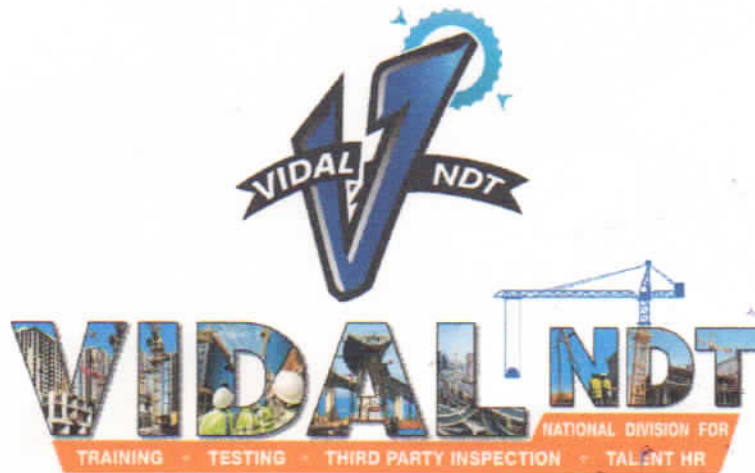


### 2. PROPOSED TECHNICAL COLLABORATION

#### 4. TERMS AND TERMINATIONS:

- a. This MOU is valid from **24 January 2022** to **23 January 2026**
- b. Unless extended by mutual written agreement of the participants, this MOU expires in **Four years** after its enforcement; which is from the date specified on the MOU.
- c. This MOU may be amended or terminated earlier by mutual written agreement of the parties at any time.
- d. However, early termination of this MOU, whether mutual or unilateral, shall not affect the interests of the participants and confidentiality of participants are to be taken at most importance of all & any other agreement entered into pursuant to this MOU, which obligations shall survive any such termination.

Nothing in this MOU makes the either party, a partner or an agent or legal representative of the other by any means.



#### 6. ASSIGNMENT


## 8. TRAINING COSTS FOR THE COURSES

10. **ROLES AND RESPONSIBILITIES OF VIDAL NDT**

11. **ROLES AND RESPONSIBILITIES OF MECHANICAL ENGINEERING DEPARTMENT OF ~~VIT~~ MIST**




**12. TERMS AND CONDITIONS:**
